# Cecil County Arts Council, Inc. OPPORTUNITY GRANT GUIDELINES

#### **PURPOSE**

To create an arts reserve account to be readily available to fund unexpected opportunities for arts programs with small grants throughout the fiscal year.

Opportunity Grants will: Foster excellence in the arts in Cecil County; provide specific project support for organizations that bring arts programs of quality to residents; encourage audience awareness of, and participation in, artistic expression in all media.

#### **WHAT QUALIFIES**

Arts programming and residencies that encourage active community participation. Applicants must be located within Cecil County. One grant per year per organization is our usual policy (special circumstances may warrant a departure from this position)

#### CONDITIONS OF APPLICATION

Application must be received at least 30 days prior to event. Grant must be for a specific project, either ongoing or one-time. The project/event must have a significant art element.

The project/event must be open to the general public, or serve a designated audience. The project/event must take place within the fiscal year (July 1 to June 30). Application form must be signed.

CCAC cannot be responsible for providing insurance coverage related to these projects. Opportunity Grants may not be used for general operating expenses.

CCAC does not currently give Opportunity Grants to projects currently funded by CCAC's CAD grant program.

#### RESTRICTIONS

Arts Council funds will not be granted for projects involving:

Capital campaigns, including purchase, construction or renovation of a facility; equipment purchases or transportation costs; profit-making or commercial ventures; retirement of existing debts; fundraising events (including cocktail parties, dinner dances, raffles, etc.); organizations which discriminate on the basis of age, sex, religion, race or ethnicity; unrelated administrative costs, tuition, and individual travel.

#### **CONDITIONS OF AWARD**

If a grant is awarded, the applicant must agree to the following conditions:

Grants may not be more than 50% of the total cost of the projects nor may they exceed \$500. For requests exceeding \$500, the artist or organization should seek a nonprofit partner and apply to CCAC's Community Arts Development grant program, the annual deadline for which is in August.

Applicant must notify the Cecil County Arts Council, Inc., of any major changes in the project as outlined in the application.

Applicant must provide the Cecil County Arts Council with complimentary tickets to the event, if requested, and give recognition for the grant funds on publicity materials and social media. In promotional material, advertising, or programs, it will be so noted "the program/event was funded in part by a grant from the Cecil County Arts Council, Inc. Print size must be in accordance with ADA (Americans with Disabilities Act) requirements (minimum 10-point type).

A final report must be provided to the Arts Council within 30 days after the program.

#### **EVALUATION CRITERIA**

In conjunction with conditions and restrictions, the Arts Council will consider the following criteria when approving applications: artistic quality; support by the community; feasibility of the project; uniqueness of the project to further the applicant's artistic program; and strength of the project to further the mission of the Arts Council.

#### **REVIEW PROCESS**

The grant panel will make all final funding decisions.

In the case of a competitive grant year, grants may be awarded in amounts less than the grant request.

All grant awards are subject to available Arts Council funding and may be dispersed in installments.

#### REPORTING RESPONSIBILITIES

Recipients of the grant funds will be expected to comply with all of the criteria above. In addition, grant recipients will be required to keep accurate financial records showing how grant funds were used. A final narrative in the form of a one-page letter describing

the event and final budget figures will be required of the grant recipient within 30 days of completion of the project. It is the sole responsibility of the preparer of the grant application to ensure all compliance with all conditions, forward all reporting requirements and maintain contact with CCAC regarding grant updates. Failure to comply with these requests will jeopardize future funding.
